

## **Agreement of cooperation**

World of Wildlife foundation, established in Tilburg, The Netherlands, below called "WOW" and the Limbe Wildlife Centre, established in Limbe, Cameroon, below called "LWC" have agreed to cooperate according to the articles in this document.

### **1. Goal of cooperation**

WOW will raise funds for LWC and LWC will keep WOW informed about the spending of funds, about the adoption animals from LWC in the WOW programme and other information about activities at LWC that could be useful for the cooperation. The cooperation has always be in line with the ethical, legal and statutory regulations.

### **2. Duration of cooperation**

The cooperation starts at the date of subscription and will be for the period of one year. The cooperation will be silently extended for another period of one year if none of the parties will stop the cooperation formally by letter or e-mail.

The cooperation can be ended immediately if:

- a) The other party stops their activities;
- b) The other party would develop activities which are in conflict with the ethical, legal or statutory rules and regulations and therefore could harm the image of the other party.

### **3. Wildlife conservation projects**

WOW will support wildlife conservation projects that have the goal to protect, nurse, take care and/or rehabilitate animals and/or perform research about the life of animals and/or protect the natural habitat of the animals.

### **4. Description of cooperation**

- a) WOW has the goal to raise funds for wildlife projects;
- b) WOW will use the raised funds to support wildlife conservation projects;
- c) WOW will pay the raised funds for LWC minus the agreed costs of administration of WOW at least ones every 6 months to LWC;
- d) LWC will take care that the paid funds will be spend on the project in a proper way;
- e) LWC will hand over all information to WOW that is important or useful for the cooperation and will inform WOW on frequent basis about the activities of LWC and the spending of funds.

### **Additional description of the cooperation concerning adoption programmes:**

- a) WOW offers adoption programmes for a single price of € 35,00. The donator will be adoption parent of the chosen adoption animal for one year;
- b) When the price of the adoption will change, WOW will inform LWC at least one months prior to the change;
- c) WOW will send an adoption package with a colour Photo, an adoption certificate and background information about the adopted animal to the donor;
- d) WOW will supply the adoption parents with information about the project and the adopted animal during the adoption period;
- e) The adoption automatically expires after one year unless the donator is willing to renew the adoption by paying for another year or per month;
- f) LWC will offer WOW all information that is important or useful for the adoption and will send at least ones every six months a new digital photo from the animals in the adoption programme.
- g) WOW is obliged to be open to all (potential) donators which project will be supported with which adoption;
- h) After the cooperation has ended it is no longer allowed for WOW to offer adoptions that have been offered by LWC.
- i) After ending the cooperation LWC is obliged to supply WOW with all the information as mentioned before until the last adoption would normally be ended (maximum one year).

**5. Costs**

- a) WOW has the obligation to pay at least 80% of the for LWC raised funds to LWC, unless agreed otherwise;
- b) The amount of costs per adoption that will be deducted by WOW for administrative costs will be 0 (zero) euro;
- c) WOW will inform LWC at least one month before any change in the costs per adoption that will be deducted by WOW for administrative costs;
